### **STRATHBOGIE PLANNING SCHEME Notice of Preparation of Amendment Amendment C04**

The Strathbogrie Shire Council has prepared Amendment C04 to the Strathbogrie Planning Scheme. The land affected by the amendment includes 57 individual sites and 9 precincts across the municipality. The amendment proposes to apply the Heritage Overlay to the individual sites and precincts.

Any person who may be affected by the amendment may make a submission to the planning authority. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the Amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for Council to consider submissions and to notify such persons of the opportunity to attend Council meetings and any public hearing held to consider submissions. In accordance with the Planning and Environment Act 1987, Council must make available for inspection a copy of any submissions made.
